## Club Officers

This month I am including information from our clubs bylaws about the duties of our club officers to encourage some of us to volunteer. The officers include a President, a Vice President, a Secretary and a Treasurer. Three directors are also elected each year to serve with the other officers on the board of directors. These folks oversee the operation of the club. In a practical sense they must often see to it that everything gets done for our shoots and the many details of maintaining our property and fulfilling legal obligations, eg: testing the well water and inspecting smoke detectors, etc.

### From our Bylaws Section 5. **Duties of President:**

The President shall be the chief executive officer of the corporation and shall, subject to the control of the Board of Directors, supervise and control the affairs of the corporation and the activities of management. He or she shall perform all duties incident to his or her office and such other duties as may be required by law, by the Articles of Incorporation or by these by laws or as may be assigned from time to time by the Board of Directors. Unless another person is specifically appointed as the Chair Person of the Board of Directors, the President shall preside at all meetings of the Board of Directors. Except as otherwise expressly provided by law, by the Articles of Incorporation or by these by laws, he or she shall, in the name of the corporation, execute such deeds, mortgages, bonds, contracts, checks or other instruments which may from time to time be authorized by the Board of Directors. He or she shall appoint committee chairmen and special committees except when provisions for such appointment are specified in these by laws. He or she shall be an ex-officio member of all committees or sub-committees. He or she shall become familiar with the duties of the other officers and instruct each officer concerning such duties.

### Section 6. **Duties of Vice President**

.. The Vice President shall take the President's place if it is necessary for the President to leave the chair or if a motion under consideration is one in which the President has a personal interest. He or she shall also handle all awards such as trophies, ribbons, medals and the like. He or she shall have a list of awards available and have them ready at the appropriate time and place.

### Section 7. **Duties of Secretary**

The Secretary shall: a. Certify and keep at the principal office of the corporation the original, or a copy, of these by laws as amended or otherwise altered to date. b. Keep at the principal office of the corporation or at such other place as the board may determine, a book of minutes of all meetings of the directors, and, if applicable, meetings of committees of directors, recording therein the time and place of holding, whether regular or special, how called, how notice thereof was given, the names of those present or represented at the meeting and the proceedings thereof. c. See that all notices are duly given in accordance with the provisions of these by laws or as required by law. d. Be custodian of the records. e. Exhibit at all reasonable times to any director of the corporation, or to his or her agent or attorney, on request thereof, the by laws and the minutes of the proceedings of the directors of the corporation. f. In general, perform all duties incident to the office of Secretary and such other duties as may be required by law, by the Articles of Incorporation or by these by laws or as may be assigned from time to time by the Board of Directors.

**Section 8. Duties of Treasurer** The Treasurer shall: a. Have charge and custody of, and be responsible for, all funds and securities of the corporation, and supervise deposit of all such funds in the name of the corporation in such banks, trust companies or other depositories as shall be selected by the Board of Directors. b. Receive and give receipt for, monies due and payable to the corporation from any source whatsoever. c. Disburse, or cause to be disbursed, the funds of the corporation as may be directed by the Board of Directors, taking proper vouchers for such disbursements. d. Keep and maintain adequate and correct accounts of the corporation's properties and business transactions, including accounts of its assets, liabilities, receipts, disbursements, gains and losses. e. Exhibit at all reasonable times the books of account and financial records to any director of the corporation, or to his or her agent or attorney, on request therefore. f. Render to the President and directors, whenever requested, an account of any or all of his or her transactions as Treasurer and of the financial condition of the corporation. g. Prepare, or cause to be prepared, and certify, or cause to be certified, the financial statements to be included in any required reports. h. In general, perform all duties incident to the office of Treasurer and such other duties as may be required by law, by the Articles of Incorporation of the corporation or by these by laws or as may be assigned from time to time by the Board of Directors.

### Important Note:

Reminder: Tree stands are to be removed from the club grounds at the end of each season. This is to discourage theft, comply with all state and club regulations, and to give all members an equal start at the beginning of each season. Some stands have been left out on the Red range. Please remove them. Thank you for your support of archery.
